MEMORANDUM

SUBJECT: Committee on Resolutions Report

- 1. The Committee on Resolutions convened at 9:00 a.m., 18 August 2024, in room 141 of the Huntington Place Convention Center in Detroit, Michigan. There were 59 voting members present, and 35 states and territories represented. The committee adjourned at 3:13 p.m. on 19 August 2024.
- 2. The Committee considered 27 resolution proposals submitted by member states and territories in accordance with the EANGUS By-Laws. Of these 27 proposals, 21 were recommended for adoption. Further, the Committee has proposed and recommended one additional resolution for separate consideration, for a total of 22 proposals recommended for adoption and six not recommended.
- 3. As provided by the EANGUS By-Laws, only those resolution proposals that the Committee recommends for adoption will be reported to the Conference. Those proposals not recommended by the Committee are attached as a written enclosure to this report (Article VIII, Section 3, Standing Committees).
- 4. To eliminate any confusion, the proposal numbers listed as recommended for adoption by the Committee coincide with the original Resolution Proposals Report electronically distributed to the membership prior to the Conference. They have *not* yet been renumbered. Upon adoption by the delegates to the Conference, they will be renumbered in sequence as EANGUS Standing Resolutions. A full, updated report of 2024 Resolution Proposals, including committee recommendations and approved amendments, is attached to this report.
- 5. For clarity of process, I will next move to adopt all but the final recommended proposal as a block. I will list only the proposal number. Specific titles will not be read but are listed in the written report filed with the Secretary. If any delegate disagrees with the proposed recommendations of the Committee, they should be prepared to identify the specific resolution and request further discussion or make a motion to withdraw the resolution from the block after the motion to adopt has been made. Lastly, as the motions that follow come from the Committee, they require no second.
